The counsel for the petitioner submitted that the present levelised tariff for the first five year will be around Rs.5.30/unit and the variable cost will be reviewed once in 3 years. The standing counsel for respondent submitted that TANGEDCO has entered recently Medium Term Agreement with PTC at a rate of Rs.4.24 (ex-bus) and NLC India Ltd., have also offered an in-principle proposal to supply power at a cost of Rs.4/unit from one of the stressed assets which NLC India Ltd., is going to bid in the tender to be invited.
