Both side present. Thiru. Rahul Balaji, Advocate appeared for the petitioner. Thiru. M.Gopinathan, Standing Counsel appeared for TANGEDCO. Arguments heard. The Chief Engineer (PPP), TANGEDCO submitted that the petitioner has not achieved the financial closure and hence the rates to be fixed can only be prospective. He further submitted that the power is available in the market at Rs.4.02 per unit as compared to the rate of Rs.4.65 (Fixed Cost at Rs.2.20/- + Variable Cost at Rs.2.45/-) offered by the petitioner and the Generators are ready to supply at the said rate upto 7 months in a year and without insisting for fixed cost for the period during which power is not drawn by TANGEDCO. The Commission directed the petitioner to further offer discount in the

fixed cost to which the petitioner agreed. The petitioner further submitted that it is developing infrastructure for the evacuation of power on behalf of TANTRANSCO and CoD would be achieved in four months from the date of financial closure. The CE/PPP further submitted that what is being quoted by the petitioner is a levelised tariff and the actual cost may be much more. However, Thiru.Sathya Kumar, Vice-President of M/s.SEPC Power Private Limited stated that the rates quoted by the petitioner is a frozen one. The counsel for the petitioner is directed to file the details on the above issue in the form of written submission within two days. The case is adjourned to 17-09-2019.
