Additional Surcharge Petition does not deserve part admission for the following reasons:-

- (1) The Licensee has not filed Tariff Petition in accordance with the section 64 (1) of the Electricity Act, 2003 and regulation 6 (1) of terms and conditions for determination of Tariff Regulations, 2005.

- (2) Only when a Tariff Petition is filed, true-up of accounts can be taken up and after prudent check of accounts, revenue requirements and revenue gap can be arrived at to determine various rates and charges. Further, as per National Tariff Policy, 2016 Cross Subsidy Charge and Additional Surcharge should not be show onerous as it eliminates competition. This is possible only when the Tariff Petition is filed and prudent check of accounts is done.
- (3) Regulation 88 on tariff determination regulation covers Additional Surcharge Regulation 24 (3) of Grid Connectivity and Intra-State Open Access Regulations, 2014 prescribed the obligations of Licensee. In Tariff Petition No. 1 of 2017 dated 11-08-2017 in page 309, it has been recorded that the Licensee has not proposed Additional Surcharge. In the same order, after true-up of accounts certain amounts were disallowed as impermissible while arriving at fixed cost summary. Despite remainders dated 16-03-2020, 23-05-2020, 20-07-2020 and 14-08-2020, the Licensee has not filed Tariff Petition and the Commission has foregone substantial revenue in the form of Tariff Petition Fee.
