This Miscellaneous Petition stands preferred by the Petitioner M/s. GMR Energy Trading Ltd., New Delhi with a prayer to-

- (i) admit and allow the present petition;
- (ii) direct execution / implementation of the order of the Commission dated 15-03-2022 passed in D.R.P. No. 02 of 2022 and direct Respondent No.1 to 4 to pay GETL an amount of Rs.2,49,75,277/- (Rupees Two Crore Forty Nine Lakhs Seventy Five Thousand Two Hundred and Seventy Seven only);
- (iii) direct attachment of bank account or any other suitable measure / directions of Respondent No. 1 to 4 to ensure compliance and implementation of the Commission's order dated 15-03-2022;
- (iv) direction of Respondent No.1 to 4 to pay further interest on the amount of Rs.2,49,75,277/- (Rupees Two Crore Forty Nine Lakhs Seventy Five Thousand Two Hundred and Seventy Seven only) as the same remains unpaid even after the 30 days from the date of the D.R.P.No.2 of 2022 order;
- (v) initiate proceedings under section 142 of the Electricity Act, 2003 against Respondent No.1 to 4 for failure to comply with the directions of the Commission;
- (vi) direct Respondent No.1 to 4 to reimburse the court fee and legal cost incurred by the petitioner in relation to the Case No. D.R.P. No. 2 of 2022 and also the

present petition since Respondents have knowingly and deliberately not complied with the D.R.P. No. 2 of 2022 till date.

This petition coming up for hearing on 23-01-2023 in the presence of Tvl. N. Kumanan and A.P. Venkatachalapathy, Standing Counsel for the Respondents and on consideration of the submission made by the Counsel for the Petitioner, Thiru Suhael Buttan and Thiru Vineet Kumar that TANGEDCO has made the required payments and hence the petitioner does not want to pursue further in this matter and on perusal of relevant materials, this Commission passes the following:
