TANGEDCO shall provide accurate demand forecast by balancing the generation from all sources including solar and wind. For this purpose, Resource Adequacy Study shall be undertaken by TANGEDCO for projecting more accurate forecast of demand so as to decide on the quantum of power to be procured during evening peak hour on long term basis. The shortage of power during peak hours may have to be examined in detail so as to avoid contracting for the whole year when the shortage is only during few months. TANGEDCO may undertake the RAS either on its own or engage professional consultants for ensuring more or less accuracy. The case is adjourned to 23.01.2024 for informing the progress in undertaking Resource Adequacy Study and for admission.
