(1) The power dispatched from M/s SEPC Power Private Limited (Tuticorin) 525 MW to the grid on pass through basis as per the guidelines issued by the Ministry of Power, Government of India dated 05.05.2022 under Section 11 of the Electricity Act, 2003 from 30-04-2022 to 30-11-2022 is hereby ratified.

(2) The cost of generation of power dispatched by the Respondent to the petitioner's grid from 30.04.2022 to 30.11.2022 is allowed on pass through basis as per the rates from time to time fixed by the Expert Committee constituted by MoP vide its communication dated 05-05-2022 as a stop-gap arrangement and payment based on such rates shall be treated as an interim one with liberty to the respondent to agitate all the issues concerning the adverse impact suffered on account of Section 11 directions in the separate petition which has been preferred specifically for this purpose.

(3) To the extent of power supplied by the respondent to the petitioner's grid from 30.04.2022 to 30.11.2022 as per the guidelines of the Committee constituted by MoP, the provisions in the PPA concerning the payment for the supply of power from the respondent to the petitioner stand relaxed.

(4) Both parties shall bear their respective costs.

Thiru.N.Kumanan & Thiru.A.P.Venkatachalapathy, Standing Counsel for TANGEDCO appeared and filed additional affidavit. Tmt. Rajeswari, Chief Financial Controller / Regulatory Cell of TANGEDCO appeared. Thiru.S.Neelakanta Pillai, Thiru.C.Selvaraj and Thiru.S.Gandhi, who have offered remarks / comments in regard to the instant True-up petition present. Thiru.S.Neelakanta Pillai and Thiru.C.Selvaraj expressed their desire to argue the matter. Since hearing of arguments from the stakeholders who have presented their comments or remarks to the matters covered under the True-up petition is alien to the proceedings and generally the Commission used to decide the true-up petition on consideration of the averments made in the petition, written comment or remarks submitted by the stakeholders and reply given by the TANGEDCO in regard to query raised by the stakeholders in their written remarks / comments, the Commission informed Thiru.S.Neelakanta Pillai and Thiru.C.Selvaraj that order will be passed on the True-up petition considering the objections / remarks / comments raised by them and that oral arguments cannot be entertained.

Thiru.S.Neelakanta Pillai and Thiru.C.Selvaraj, who did not heed what the Commission said, while persisting their demand behaved themselves in a disobedient / disrespectful manner that defied the authority, justice and dignity of the Commission. The disparaging remarks made by Thiru.S.Neelakanta Pillai and Thiru.C.Selvaraj in open court which tend to scandalize and lower the authority of the Commission tantamount to interfering with the due course of the judicial proceedings and obstructing the administration of justice. The conduct of Thiru.S.Neelakanta Pillai and Thiru.C.Selvaraj is nothing short of contempt of court inviting appropriate action. This Commission is not contemplating any contempt proceedings against them at present so as to provide them an opportunity to mend their activities in the future. However, it is made clear that such misbehavior, if repeated, will not be tolerated and stringent action will be initiated against the contemnors. Order reserved.
