Taking into account of all the submissions made by the petitioners, the Commission hereby ratify and accords approval for the procurement - 300 MW RTC power at rate of Rs.8.90 per unit for the period from 10thApril 2022 to 20th May 2022 from M/s. IL&FS through M/s. Manikaran Power Limited, and, another 300 MW RTC power from 28.04.2022 to 20.05.2022 from M/s. KSK Mahanadhi Power company Limited through M/s.Manikaran Power Limited under Tender No.21 of 2022. Commission also approves for the deviations adopted in Short term tender guidelines of MoP, as below.

- (i) deletion of payment security clause viz opening of Letter of Credit,
- (ii) deletion of Contract Performance Guarantee clause
- (iii) to release the BG/EMD after the fulfilling the contractual obligations
- (iv) to fix the validity of the tender 30 days from the date of e-Reverse Auction process (excluding the date of e-RA).
- (v) deletion of change in law clause

And also, Commission ratify and approve to adopt the tariff rate of Rs.8.90 per unit for the procurement of 300 MW (RTC power) for the total period of 10thApril 2022 to 20th May 2022”. Ordered accordingly.
