“9.8. In view of the above findings, we direct that –

- (i) the petitioner is eligible for payment of Rs.48,02,128/- since the petitioner has not breached the scheduling of 80% of the contracted quantum during the “Scheduling period” as defined under Clause 5 of the PTC’s Order dated 03.07.2009. Any revised procedure stated by the PTC in its letter dated 16.11.2009 which amounts to amendment to the Agreement will take effect only from the date of receipt by the petitioner, and it cannot be given effect retrospectively. And thus the claim is to be settled by the 1<sup>st</sup> Respondent along with the interest @ 12% per annum.
- (ii) The petitioner has not provided documents for recovery of EMD amount of Rs.10,51,594/-, but the 1<sup>st</sup> Respondent has provided a documentary evidence for deduction of Rs.3,30,000 from the 27.5.2010 invoice. Hence we direct for refund of Rs.3,30,000 to the petitioner alongwith the interest @ 12% per annum.
