DAILY ORDER

Tvl. N.Kumanan and A.P.Venkatachalapathy, Standing Counsel for the petitioner appeared. The counsel for the petitioner sought approval for procurement of 200 MW at tentative cost of Rs.2.72 per kWhr and 300 MW at tentative cost of Rs.2.73 per kWhr totaling to 500 MW from SECI to meet out the other Renewable Purchase Obligation (RPO) at MNRE. The Chief Engineer/NCES & Executive Engineer/NCES of TANGEDCO presented case of the petitioner. The officials of TANGEDCO submitted that there would be still shortfall of 2600MW in the RPO target even after this procurement and considering reasonableness of the rates, the present proposal may be approved by the Commission. The Commission queried the TANGEDCO officials as to why the procurement from the wind cannot be tried as the said source of power would be handy in the evening peak hours and directed TANGEDCO to study the possibility of procurement from Wind. Commission advised TANGEDCO to purchase within the State to avoid corridor issues and line loss and if at all, power is to be purchased from outside, swapping may be done to avoid line loss and corridor issues. Commission further advised TANGEDCO to go for distributed generation to avoid line loss and also

to explore the possibility of implementing KUSUM-C to avail 1.5 crore which is available as subsidy under the said scheme. Commission further directed TANGEDCO to go for tariff based bidding and avail loan from REC to avail concessions. Petition admitted. TANGEDCO is permitted to go ahead with the procurement process. Order reserved.
