- (iii) Release the BG/EMD after the fulfilling the contractual obligations
- (iv) Fixing the validity of the tender 30 days from the date of e-Reverse Auction process (excluding the date of e-RA).
- (v) Deletion of Change in Law clause

The tariff rate of Rs.8.50 per unit is also approved for the procurement of 1022 MW during 01-03-2023 to 20-05-2023 subject to the observations and directions in paras 5.16 to 5.18 of this order. Ordered accordingly”.

“18) In the result this Review Petition stands allowed. The earlier order passed by this Commission in M.P.No.14 of 2012; DRP No.28 of 2012; M.P.Nos. 21 to 23 of 2014 and M.P. No.45 of 2014 dated 05.10.2021 is reviewed and modified in as far as appointment of State Power Committee is concerned. The Power System Operation corporation now renamed as Grid Controller of India Limited shall review the back down instructions issued by TANGEDCO / SLDC to the Generators and verify as to whether the curtailments have been made in accordance with directions of APTEL incorporated in the judgement dated 02.08.2021 passed in Appeal No.197 of 2019. Further it is hereby made clear that this order is confined to this particular case alone. Parties shall bear their respective costs.
