She wanted the withdrawal of the conditions set out in the covering letter to the DISCOM certificate. The counsel representing TANGEDCO submitted that no such conditions have been introduced and the DISCOM certificate issued by it consequent to the interim direction of the Commission has not imposed any condition. As prayed for by the Counsel for the Petitioner, and agreed to by the Counsel for the Respondent, the parties shall strictly abide by the order dated 09-03-

2023 of the Commission and the certificate issued by the TANGEDCO thereafter. The I.A., as prayed for by the petitioner stands disposed in view of the certificate issued by TANGEDCO. Both side to argue on main petition and file a status report on procurement on Indian coal in the next hearing.
