- (c) The Late Payment Surcharge so worked out shall be paid by the respondents to the petitioner within thirty days from the date of this order.

- (d) If the respondents fail to settle the amount within the stipulated period, the respondents shall pay interest on the worked out amount at the rate of 6 per cent per annum from the date of this petition till the date of realization.
- (e) Parties shall bear their respective costs.
