“The additional surcharge of Re.0.83 per kWh is collectable by the petitioner for the “Open Access” (OA) drawn from 25-02-2023 to 31-03-2023. Though the petitioner has claimed to charge the additional surcharge from 01.10.2022 to 31.03.2023 in its petition, the Commission is not inclined to levy such surcharge retrospectively duly considering the dynamic transactions held by OA consumers taking into account of the prevailing OA charges at that time”. Petition ordered accordingly.
