**10.26** In the result the petition is ordered in the following terms:

- (a) The Petitioner SEPC is permitted to procure imported coal, as an interim arrangement, for the supply of power to the Respondent TANGEDCO.
- (b) The Petitioner SEPC shall make all earnest endeavour to procure imported coal at the cheapest price prevailing in the market. Further the cost of the procured imported coal shall not exceed the Argus index price during that period.
- (c) The above referred interim arrangement for supply of power by the Petitioner SEPC to the Respondent TANGEDCO shall be valid only until SEPC procures domestic coal linkage and commences supply of power using domestic coal supplied through the linkage.
- (d) For obtaining domestic coal linkage the Petitioner SEPC shall take all the necessary steps in an expeditious manner. In this regard the Petitioner and the Respondent are at liberty to approach this Commission within 3 months from the date of this Order and appraise the Commission about the status of domestic coal linkage.

- (e) The Petitioner SEPC and the Respondent TANGEDCO are directed to amend the relevant Power Purchase Agreement on the basis of interim orders passed by this Commission on 09.03.2023; 13.06.2023 and 20.06.2023 and also the present order. The copy of the amended PPA shall be submitted before this Commission for approval within 15 days from the date of this Order.
- (f) Considering the nature of issues involved in the case, parties directed to bear their respective costs.
