- (i) Two-part tariff basis for 240 MW power, delivered at RGPPL Ex-Bus with,
 - (a) Fixed Cost will be on contracted quantity of 240 MW (Rs.27.67 Crores / Month)
 - (b) ECR: Based on the actual Gas Price and Pass through.
- (ii) ECR of Rs.7.87 per KWh is based on following
 - (a) 0.3 MMSCMD NAPM Gas @ 6.1\$/ MMBTU
 - (b) RLNG Ex-terminal Price 13.16\$ / MMBTU
 - (c) Exchange Rate: 77 Rs/USD (Pass through)
 - (d) Heat Rate: 1900 Kcal/KWh & APC: 3%

- (iii) Block wise minimum scheduling of 90% of contracted quantity.
- (iv) Connectivity for power evacuation RGGPPL is Maharashtra STU connected.
- (v) Power Scheduling will start necessary order from MoP Further, the procurement of 132.48 MU from M/s.RGPPL during the period from 11th April 2022 to 10th May 2022 is hereby approved and ratified”.

DAILY ORDER

Counsel for the Petitioner M/s.SEPC Power Private Limited and the Counsel for the Respondent CMD/ TANGEDCO present. The learned Counsel for the Petitioner by informing that CSTA has been terminated by JERA prayed for approval of the termination of CSTA by the Commission. The Counsel for the Respondent who concurred with the above submission stated that TANGEDCO has no objection in termination of CSTA provided that there is no financial implication on TANGEDCO on this count.

The learned Counsel for the Petitioner further submitted that the petitioner's machine has been designed to operate at higher calorific value (i.e) around 5000 GCV with International Coal and that since the price of the imported Coal has risen manifold in the International market, it is practically impossible for the petitioner to operate the SEPC machine with imported Coal as the same would cause financial loss to the

petitioner. The Counsel for the Petitioner stated that the Petitioner's machine cannot be operated with Talchar Coal due to its low calorific value. Based on the above submissions, the petitioner's Counsel requested the Commission to direct the Respondent TANGEDCO to issue No Objection Certificate (NOC) to facilitate the petitioner to have a Fuel Supply Agreement (FSA) for supply of Indian Coal with high Calorific value. The Counsel also requested for removal of ceiling price for Indian Coal.

The Counsel for the petitioner further submitted that the petitioner is agreeing to supply power to the respondent TANGEDCO under pass through mechanism declared by Ministry of Power (MoP) under Section 11 of the Electricity Act, 2003 provided liberty in accorded to the petitioner to file petition to claim compensation under Section 11 (2) of the Electricity Act in case the rate fixed by MoP is not adequate. The Counsel for the Respondent who did not raise any serious objection in this matter impressed upon the Commission that the Petitioner shall supply power to TANGEDCO under Section 11 of the Electricity Act.

On consideration of the rival submissions this Commission is inclined to pass the following Interim Order in the best of interest of both the parties.

1) Termination of CSTA by JERA is hereby approved by the Commission. The Petitioner SEPC is directed to get FSA / Coal Linkage from Coal India Ltd (ECC/SCCL) expeditiously.

2) The respondent TANGEDCO shall give NOC to facilitate the petitioner SEPC to procure the Fuel Supply Agreement for arranging suitable Domestic Coal for running their machine from the Indian Coal field. There will not be any ceiling price on the Indian Coal.

3) The Petitioner SEPC shall commence supply of power to the Respondent TANGEDCO on pass through basis as per the rates fixed by the Ministry of Power and as revised from time to time by MoP. The Petitioner is given the liberty to approach the Commission for offsetting the financial impact or to claim compensation under Section 11 of the Electricity Act 2003, with necessary documents in support of its claim.

Matter adjourned to 28.03.2023 for further hearing in the Main Petition.
