**ORDER:-**

In the Government Order first read above orders have been issued fixing the Fixed Pay of the Chairman and Members of the Tamil Nadu Electricity Regulatory Commission as follows initially with effect from 01-01-2006 with monetary benefit from 01-01-2007.

2 The Fixed Pay for the Members of the Tamil Nadu Electricity Regulatory Commission was fixed at Rs. 70,380/- p.m in the G.O first read above based on the revised scale of pay of Rs. 37,400 – 67,000 + Grade Pay of Rs. 12,000/- for the pre-revised scale of Pay of Rs. 22,400 – 24,500 and the corresponding Pay for Rs. 24,500/- was Rs. 58,380 + Grade Pay Rs. 12,000/-

The Government of India in the Office Memorandum second read above has communicated the replacement of the pre-revised S-30 Pay Scale (i.e.) Rs. 22400 – 24500 by a new HAG Scale of Rs. 67000 (annual increment at 3%) – 79000 as notified vide G.S.R. No. 527(E), Dated: 16-07-2009. As per the revised fitment table, the stage for the pre-revised basic pay of Rs. 24,500/- in the revised Pay Scale is Rs. 75,420/-.

3. The Secretary Tamil Nadu Electricity Regulatory Commission in the letter third read above has requested to refix the Fixed Pay for the Members of the Tamil Nadu Electricity Regulatory Commission at Rs. 75,420/- in accordance with HAG Revised Scale of Rs. 67000 (annual increment at 3%) – 79000 as communicated in the Office Memorandum of the Government of India second read above.

4. Government after careful consideration has decided to refix the Fixed Pay of the Members of the Tamil Nadu Electricity Regulatory Commission and accordingly in partial modification of the orders issued in the G.O. first read above, Government direct that the fixed Pay of the Members of the Tamil Nadu Electricity Regulatory Commission be revised as Rs. 75,420/- p.m. notionally with effect from 01-01-2006 and with monetary benefit from 01-01-2007.
