Tamil Nadu Electricity Regulatory Commission – Sanction of staff cars for the Members of Tamil Nadu Electricity Regulatory Commission and two drivers – Orders – Issued.

ORDER:

In the G.O.1st read above, orders have been issued for formation of State Electricity Regulatory Commission (SERC)under the Electricity Act, 1998 (Central Act 14 of 1998) and framing of rules for conditions of service of Chairman and Members of the Commission.

2. In the letter 2nd read above, the Chairman, Tamil Nadu Electricity Regulatory Commission has requested the Government to sanction two staff cars along with two posts of drivers. He has also stated that the Members of Tamil Nadu Electricity Regulatory Commission are provided with hired air-conditioned cars. The service conditions of the Members of the Commission should not be inferior to those members of the Tamil Nadu Electricity Board who have been provided with chauffer driven staff cars. The Members of the Commission are eligible to have new cars of their choice with a price ceiling of Rs.8.50 lakhs ex-showroom price inclusive of taxes in addition to the registration charges (excluding insurance) with 5% indexation annually for price increase in future as per order in G.O.Ms.No.297, Home (Transport IV) Department, dated: 25.5.2008. He has further requested the Government to sanction two Honda City 1.5 EMT cars for two members at a cost of Rs.9.11 lakhs each along with two posts of drivers.

- The Government have examined the proposal of Tamil Nadu Electricity Regulatory Commission and decided to accept the same. Accordingly the Government:
 - (i) Permit the Tamil Nadu Electricity Regulatory Commission to purchase of two Honda City 1.5 EMT cars for two members of the Commission at a cost of Rs.9.11 lakhs each totaling Rs.18.22 lakhs inclusive of taxes and registration but excluding insurance; and
 - (ii) sanction two posts of drivers for the above two cars in the payband-1 Rs.5200-20200+Grade pay Rs.2000/subject to the condition that the driver posts shall be filled up through TEXCO / outsourcing.
- 4. So far, a sum of Rs.3,97,59,000/- (Rupees three crores ninety seven lakhs fifty nine thousand only) has been released to Tamil Nadu Electricity Regulatory Commission as grants-in-Aid for the year 2010-2011. The expenditure in connection with the permission accorded in para-3 above may be included within the grants released to Tamil Nadu Electricity Regulatory Commission.
