ORDER:

In the Government Order first read above, orders were issued sanctioning regular staff to the Tamil Nadu Electricity Regulatory Commission for attending day to day functions wherein, Government have, inter alia, sanctioned one post of Marshall to the Legal Wing of Tamil Nadu Electricity Regulatory Commission in the scale of pay as applicable in the Judicial Department of the State Government.

2. The Secretary, Tamil Nadu Electricity Regulatory Commission in the letter second read above has stated that, the Registrar (Administration) High Court of Madras, Chennai has informed that the post of Marshall does not exist in the Madras High Court service and that an office Assistant attached to the Hon'ble Judge's chamber functions as chobdar and the scale of pay of the post is Rs.2550-55-2660-60-3200 (pre-revised). In view of this, he has requested Government's permission to fill up the post of Marshall in the Legal Wing in Tamil Nadu Electricity Regulatory Commission by appointing an official in the [Pre-revised scale of pay of Rs.2550-55-2660-60-3200]. Revised Pay Band PB-1A Rs.4800-10,000/-+ Grade pay Rs.1300/- as in the case of Chobdar in the Madras High Court Service.

3. The Government, after careful examination, has decided to re-classify the nomenclature of the existing post of Marshall in Tamil Nadu Electricity Regulatory Commission as Chobdar and permit Tamil Nadu Electricity Regulatory Commission to fill up the post in the revised pay Band PB-1A Rs.4800 -10,000/-+G.P.1,300/- as available in the Madras High Court Services:

4. Accordingly, the following amendment is issued to G.O. Ms.No.80, Energy (A1) Department , dated:19.08.2002:-

AMENDMENT

In the said Government Order, in paragraph 1, under the heading "VI. Legal Wing", for the expression "Marshallone (Scale of pay as applicable in the Judicial Department of State Government)", the expression.

"Chobdar". one (Revised Scale of pay in pay Band -1 A Rs.4800-10,000+Grade pay Rs.1300/-shall be substituted.
