### Tamil Nadu Electricity Regulatory Commission

#### Public Hearing on TNEB's Tariff Petition

Tamil Nadu Electricity Board have filed a tariff revision petition on 18-01-2010 before the Tamil Nadu Electricity Regulatory Commission for revision of the existing electricity tariff to the following categories of consumers.
