EMPLOYMENT / RECRUITMENT NOTICE

Tamil Nadu Electricity Regulatory Commission (TNERC) is a statutory body constituted by the Government of Tamil Nadu and located at Chennai discharging its function under the Electricity Act, 2003. It is vested with powers to determine the electricity tariff and to regulate power purchase and procurement process, issuing licenses and adjudicate upon disputes. TNERC is looking for suitable candidates to fill up the post of **Secretary and Director (Engineering)** either on deputation or on contract basis. The Qualifications and experience required for the post of Secretary and Director (Engineering) are separately given below.

Secretary: One post

Director (Engineering): One post

| Experience | 20 years of engineering experience out of which at least 7 years at management level in a large power utility with generation, transmission and distribution facilities. |
| Desirable experience | Hands-on experience in setting up power projects and critically reviewing their standards of performance. Good knowledge of electricity laws and exposure to electricity regulatory reforms. |

The qualifying service, pay and age limit required for these two posts are given below.

| Qualifying Service | Should have served in Grade I posts drawing grade pay of Rs.8,700/- and above or its equivalent. |
| Pay | (a) If on deputation as per the Last Pay Certificate plus applicable allowances for the post. (b) If on contract last pay drawn minus pension as per Tamil Nadu Pension Rules, 1978 plus applicable allowances for the post (or) The Commission would fix a monthly fixed consolidated emoluments based on qualification and experience |
| Age | If on deputation minimum 55 years of age. If on contract should have completed 55 years with a maximum age limit of 62 years and shall cease to hold the post after he / she attains the age of 65 years. |

Those who are working in Government / Public Sector Undertakings / Corporations / Boards / Electricity Boards / State Electricity Regulatory Commissions and desire to come on deputation will be covered under Foreign Service Terms and conditions of Government of Tamil Nadu. Such candidates should apply for the above posts through proper channel with a “No Objection Certificate” from their employers. However, an advance copy may be sent directly by the candidate to avoid delay and shall produce the above certificate prior to interview, if called for. The period of deputation or on contract shall be for a period of one year initially, which may be extended on year to year basis.

Mere fulfilling of eligibility criteria shall not bestow any right to be called for interview. Only short-listed candidates shall be called for an interview. TNERC reserves the right to keep these posts unfilled depending upon the circumstances prevailing at the time of selection. The Commission shall have full discretion to fill up the post either by deputation or through contract basis. The Commission’s decision in this regard shall be final.
