

Sub: Electricity – Withdrawal of R&C measures presently in vogue for High Tension Industrial and Commercial

services - Orders - Issued.

From the Chairman and Managing Director, TANGEDCO D.O.Lr.No.CE/Comml/EE/R&C/AEE1/F.R&C/D.126/2014,

dated 14.05.2014.

The Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited in his letter has stated that with a view to absorbing maximum wind power, existing restriction and control measures on industrial and commercial services may be withdrawn from 1.6.2014 as below:-

- a. 20% power cut on based demand and energy for high tension industrial and commercial services during normal hours (other than evening peak hours from 06.00 P.M. to 10.00 P.M) may be withdrawn.
- b. The restriction that high tension industrial and commercial consumers shall draw not more than 10% of quota from the grid during evening peak hours (6.00 P.M. to 10.00 P.M.) for lighting and security purposes may be withdrawn.
- 2. It has been decided and announced that there will not be load shedding in the State. Thus the scheduled Low Tension load shedding also need to be withdrawn.

- 3. The Government accept the proposal of Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited for withdrawal of restriction and control measures from 01.06.2014 as below:
 - a. 20% power cut on based demand and energy for high tension industrial and commercial services during normal hours (other than evening peak hours from 06.00 P.M. to 10.00 P.M) may be withdrawn.
 - b. The restriction that high tension industrial and commercial consumers shall draw not more than 10% of quota from the grid during evening peak hours (6.00 P.M. to 10.00 P.M.) for lighting and security purposes may be withdrawn.
 - Further, the scheduled Low Tension load shedding also stands withdrawn.
