1. The Appeal Petition dated 23.3.2015 received from Thiru. T. Rangarajan, Madurai-10, was registered as Appeal Petition No. 33 of 2015.
2. The Appellant prayed to refund the deposit amount collected for the three phase meter stating that the said meter was surrendered to TNEB and he has deposited Rs.5570/- for the net meter.
3. A copy of the above appeal petition was sent to Superintending Engineer/Madurai EDC/Metro vide letter dt.1.4.2015 for furnishing his counter.
4. Superintending Engineer/Madurai EDC/Metro has furnished his counter affidavit under cover of the letter dt.18.4.2015.
5. To enable the Appellant and the Respondent to purforth their arguments in person, a hearing was conducted on 11.6.2015 before the Electricity Ombudsman.

6. Thiru. R. Kannan, Assistant Executive Engineer/South, Arasaradi has attended the hearing on behalf of the Respondent and put forth his arguments. But, the Appellant has not attended the hearing and has also not sought for any adjournment.

7. In letter dt.12.6.2015, Thiru. T. Rangarajan, the Appellant herein has stated that he is withdrawing the case filed by him. The relevant para of the said letter is extracted below :
