## Date of Order: 11.10.2017

- 1. The Petition dt. 30.5.2017 filed by Thiru. J.M. Aneez, Burma Colony, Selaiyur, Chennai was registered as Appeal Petition No.41 of 2017.
- 2. The Appellant prayed that the tree branches are touching electrical OH lines at Avvai Nagar 2<sup>nd</sup> Street, Burma Colony of Selaiyur and requested to clean it up. Further he requested to remove few electrical connections which have been hooked to the electrical post by the side of his residence.

- 3. A copy of the above petition was forwarded to the Executive Engineer/ O&M/Tambaram vide letter dt.05.06.2017 for furnishing the counter if no settlement is reached.
- 4. To enable the Appellant and the Respondent to putforth their arguments in person, a hearing was proposed on 19.9.2017. Thiru.K. Sivaraman, Assistant Executive Engineer/O&M/Selaiyur & Thiru. P. Ravi, Assistant Engineer / O&M / Selaiyur have presented themselves for the hearing. But the hearing was not conducted since the Appellant had requested to cancel the hearing on 19.09.2017.
- 5. Re-hearing of the above case has been fixed on 12.10.2017 at 11.00 AM and intimated to the Appellant and to the Respondent for appearance.
- 6. In the mean time, the Appellant has withdrawn his appeal petition vide his letter dt.10.10.2017 since his grievances were settled. The said letter is extracted below:
