(ii) TNERC Tariff Regulations 2005

The tariffs for TANGEDCO as per Tariff Order 1 of 2012 dated 30-03-2012 and that of TANTRANSCO vide Tariff Order No 2 of 2012 dated 30-03-2012 is valid only till 31-03-2012. Both the tariff orders stipulate that the licensee should file necessary petition in accordance with the Regulations in time so that the next tariff order is issued and comes into effect from 01-04-2013.

2. Regulation 5 and 6(1) of the TNERC Tariff Regulations 2005 stipulate the filing of ARR and Tariff petitions on or before 30th November of each year.

3. However, even after a lapse of one month after 30th November, TANGEDCO, TANTRANSCO and SLDC have not filed their ARR and tariff petitions before the Commission.
4. Therefore, I am directed to say that TANGEDCO, TANTRANSCO and SLDC file their tariff petitions without any further delay.

The Tariff Order No. 1 of 2012 dated 30-3-2012 was issued by this Commission fixing the Tariff for the FY 2012 - 13 and this Tariff Order is valid upto 31st March 2013. The Tariff Order for FY 2012 -13 considered commissioning of various Units within Tamil Nadu and accordingly the ARR has been worked out. These Units have not been commissioned as originally planned. Consequently load shedding has been resorted to. This change is likely to affect the following:-

- 1) Cost of Power Purchase; and
- 2) Revenue realization

The above referred Tariff Order also allowed creation of Regulatory Asset which the Government of Tamil Nadu had agreed in principle to take over. In view of the changes in the power purchase cost and revenue realization the Regulatory Asset would also under go a change. It is necessary to work out the revised Regulatory Asset. In consultation with the Government of Tamil Nadu as the Government has agreed 'in

principle* for its amortization vide Lr. No. Ms. No. 32 dated 25-3-2012. It is therefore imperative that the TANGEDCO files an ARR and Tariff petition for FY 2013 - 14 duly taking into account all the above referred issues and file the same before the Commission immediately, keeping in view that the present Tariff Order is valid only upto 31st March 2013. This may please be treated as urgent.
