**ORDER:-**

Tamil Nadu Generation and Distribution Corporation Limited filed the Tariff petition for the year 2013 – 14 under the MYT Regulation on 19<sup>th</sup> February 2013 along with an I.A. for condonation of delay of 81 days in filing this petition.

2. I.A. No. 1 of 2013 in T.P. No. 1 of 2013 was first taken up. Director Finance, TANGEDCO, Thiru G. Rajagopal presented the reasons for delay in filing the petition. Following are the reasons explained by him:-

3. The Financial Restructuring Plan (FRP) which was notified by Government of India on 5<sup>th</sup> October, 2012 was to be finalized by 31<sup>st</sup> December 2012. This involved a lot of meetings with the bankers, Government of Tamil

Nadu for taking over 50% of the short term liability amounting to about Rs.12,200/- crores, etc. Balance 50% of the short term liability which is payable by TANGEDCO has to be restructured by banks. This re-structured loans would have a moratorium period of 3 years and repayment period of 7 years.

4. This, he explained, will improve the cash flow and the liquidity position of TANGEDCO. All these exercises were done during the month of October, November and December 2012 and the Government of Tamil Nadu had issued G.O. No. 142 on 27.12.2012 regarding the FRP. Thereafter TANGEDCO had filed the petition before the TNERC on 29.12.2012 for obtaining "in-principle" approval of the TNERC for FRP and the approval of TNERC was accorded on 31.12.2012.

5. Director, Finance, TANGEDCO further clarified that the audit of accounts for the year FY 2011-12 was to be completed by 31<sup>st</sup> January 2013 and the same was done. By and large the statutorily audited figures are reflected in the petition. He further stated that after completing the activities regarding FRP and statutory audit of the accounts of FY 2011 -12, it took another 18 days for them for preparing the petition. Accordingly, he pleaded for condonation of the delay in filing the petition.

6. The Commission has been monitoring the filing of the petition vis-à-vis the due date of filing of the petition Viz., 30<sup>th</sup> November 2012. The Commission had written a letter to TANGEDCO on 8.1.2013 for immediately filing the ARR and tariff petition. The Commission had issued another letter on 21.1.2013 clearly bringing out the need for reworking out the cost of power purchase, revenue realization and more importantly the regulatory asset and its amortization duly taking into account the Government of Tamil Nadu's Letter Ms. No. 32 dated 25.3.2012. The licensee was further advised to expedite filing of the petition by another letter dated 8.2.2013. The petition was eventually filed on 19.2.2013.

7. Having perused the reasons given in the petition and further submissions made in the hearing by the Director, Finance of TANGEDCO, the Commission condones the delay of 81 days in filling this petition.

8. The petition is admitted.

9. The abridged version of the tariff proposal which is due for publication in news papers shall be submitted to the Commission by 25.2.2013 and the same will be approved by the Commission by 28.2.2013.

10. The approved abridged version may be published in two English and two Tamil news papers having wide circulation on 2.3.2013. Views and suggestions of the stake holders on the tariff proposal may be invited upto 2<sup>nd</sup> April 2013. The tariff petition of TANGEDCO both in English and Tamil shall be posted on the website of the TANGEDCO as well as TNERC for the information of all stake holders.

11. The copies of the tariff petition will also be made available for sale at a price of Rs.300/- per copy from 2<sup>nd</sup> March 2013 in all offices of Regional Chief Engineers and Electricity Distribution Circles of TANGEDCO besides the Head Quarters.

12. The Commission directs TANGEDCO to file the petition in future as per the due dates stipulated in the Regulation.

In continuation of TNERC's statutory advice tendered on 4-5-2010 and 1-11-2010, I am directed to add the following statutory advice of the Commission u/2 86 (2) of the EA 2003 on the restructuring of the TNEB.

2. The transfer scheme 2010 issued by Government of Tamil Nadu contains aggregate assets and liabilities vested in TANGEDCO and TANTRANSOCO in page nos. 23 and 29 respectively. Note No.1 of the two balance sheets are identical and is reproduced below:-

**Note:**

- 1. The above opening balance sheet has been drawn on a provisional basis based on available accounts of the financial year 2008-09 of the Board and*

*will be considered as a provisional balance sheet as on 1-11-2010 for the Transferee. The amounts mentioned under various heads are subject to validation, verification, updation and truing up and these shall be completed during the provisional period mentioned in clause 9 of the Transfer Scheme.*

3. In accordance with clause 9 of the Transfer Scheme, the Transfer Scheme shall be provisional for a period of one year from the date of transfer.

4. The balance sheet and note no.1 to the balance sheet indicate that the opening balance has been drawn on a provisional basis based on accounts of the financial year 2008-09 and will be considered as provisional balance sheet as on 1-11-2010 of the transferee. The Tariff Order issued by the Commission, based on the petition of the TNEB deals with the financial year 2010-11 onwards. The Regulatory Assets, which is actually a liability to be recovered by the utility in future years from the consumers, is a whopping Rs.7905 crores. The projection for the years 2011-12 and 2012-13 are also not flattering. The trend shows that there would be a huge revenue gap to be accounted as Regulatory Asset to the tune of Rs.6062 crores and Rs.3489 crores respectively for these years. The Tariff Order envisages that the restructuring of the TNEB is expected to address the accumulated loss of previous years, in the light of the National Electricity Policy / Tariff Policy. These policies envisage that the successor entities should start on a clean slate by appropriate financial restructuring. This issue may be addressed by the Government of Tamil Nadu appropriately by reckoning for the losses accumulated by TNEB during the period 1-4-2009 to 31-10-2010, so that consumers are not saddled with additional losses of the utility.

I am directed to convey the statutory advice of the Commission on the restructuring of the Tamil Nadu Electricity Board.

(2) The Government have approved reorganization of the Tamil Nadu Electricity Board into two entities TANGEDCO and TANTRANSCO. TANGEDCO has been entrusted with generation and distribution, whereas TANTRANSCO has been entrusted with transmission.

(3) Generation has been generally neglected in TNEB over the years, which has led to the current crisis of acute power shortage. Therefore, the Commission believes that generation needs to be exclusively handled by another Government Company. All over the country (13 States) (Annexure) have created a separate organization for generation. Apart from the fact that the generation calls for exclusive attention, a separate entity will have an attractive balance sheet. On the other hand, a combined entity for generation and distribution will

always be a losing concern because of the heavy losses inherent in the business of distribution. The combination of generation and distribution in a single organization would result in generation being neglected and distribution securing priority, as it has been happening over the years. The Commission believes that a separate entity for generation with a separate Chairman would be in public interest.

(4) Further, the Commission also believes that the distribution company should be split up into four Government Companies with headquarters at Chennai, Coimbatore, Tiruchirapalli and Madurai, as in the case of Transport Corporations, in the interest of operational convenience and consumer satisfaction. Each Company may be managed by a full-fledged Board of Directors with a full time Chairman. A monolithic distribution entity having headquarters at Chennai with a consumer base of 2.2 crores will be unmanageable. One Chairman will not be able to manage the consumer base of 2.2 crores. Tamil Nadu has the highest consumer base all over the country and it is all the more necessary to split up the distribution entity. This has been done in ten States. (Annexure). These points have been mentioned to Hon'ble Chief Minister and Hon'ble Minister for Electricity at the time of presentation of tariff order on 4-8-2010.
