

## ORDER:-

In the Government order first read above, Government have notified the provisional Transfer Scheme, transferring the assets, liabilities & personnel of erstwhile TNEB with the effective date of implementation as 1.11.2010, as per the provisions of the Electricity Act, 2003.

- In the Government order second read above the Government have extended time upto 31.10.2012 for final transfer of assets and liabilities to successor entities and erstwhile TNEB.
- 3) Now, the CMD, TANGEDCO has stated that the erstwhile TNEB has been reorganized with effect from 01.11.2010 and the successor entities have started functioning independently. The due date for final transfer of assets expires on 31.10.2012. The audited balance sheet as on 31.10.2010 has been prepared. However revaluation of asset is being undertaken by a consultant. Only after revaluation the final transfer of assets and liabilities to the Successor entities can be proceeded. At least 6 months are required to complete this exercise.



- 4) The Tamil Nadu Generation and Distribution Corporation Board has approved the proposal to seek 6 months time extension i.e., upto 30.04.2013 for final transfer of assets and liabilities to successor entities of erstwhile TNEB by way of amendment to the Tamil Nadu Electricity Regulatory (Reorganization and Reforms) Transfer Scheme 2010 notified vide G.O.Ms.No.100,dated 19.10.2010 and Amended vide G.O.(Ms.) No.2, Energy (B2) Department, dated 02.01.2012.
- The Government after careful examination, accepts the aforesaid proposal of CMD, TANGEDCO and extend the provisional period for final transfer of assets and liabilities which ends on 31.10.2012 upto 30.04.2013,
- The notification appended to this order will be published in the Tamil Nadu Government Gazette Extraordinary dated 08.03.2013.
