The first year tariff is applicable for a period of one year from the date of commissioning, the second year tariff is applicable for one year thereafter and so on. As the control period expires on 31-3-2011, it is expected that the next tariff order would be in position by then.

10.2 The tariff applicable at any point of time would be the sum of the fixed cost for that year of operation and the variable cost applicable for the relevant financial year. For example, the tariff for a plant commissioned on 19-9-2008 would be Rs.3.15 / unit upto 26-04-2009 and Rs.4.50 / unit (Rs.1.833 + Rs.2.667) from 27-04-2009 upto 18-9-2009 because the project is eligible for financial benefit only from the date of this Order namely 27-04-2009. The tariff from 19-9-2009 upto 31-3-2010 would be Rs.4.518 / unit (Rs.1.851 + Rs.2.667) and from 1-4-2010 upto 18-9-2010 would be Rs.4.651 / unit (Rs.1.851 + Rs.2.80). The tariff from 19-09-2010 upto 31-03-2011 would be Rs.4.605 / unit (Rs.1.805 + Rs.2.80) and from 01-04-2011 upto 18-09-2011 the fixed cost would be Rs.1.805 / unit and variable cost to be determined in the next tariff order. A project commissioned on 03-04-2009 would have a tariff of Rs.3.15 / unit upto 26-04-2009,

tariff of Rs.4.50 / unit (Rs.1.833 + Rs.2.667) from 27-04-2009 upto 31-3-2010 and a tariff of Rs.4.633 / unit (Rs.1.833 + Rs.2.80) from 1-4-2010 upto 02-04-2010. The tariff from 03-04-2010 upto 31-3-2011 would be Rs.4.651 / unit (Rs.1.851 +Rs.2.80) and from 1-4-2011 upto 02-04-2011 would be the fixed cost of Rs.1.851 / unit and the variable cost to be determined in the next tariff order. The illustrations are tabulated below:-

Thus, fixed cost is computed for a period of one year from the date of commissioning, whereas in regard to variable cost, the figure relevant for that financial year is taken into account.

10.3. As regards the projects commissioned between 15-5-2006 and 18-9-2008, the tariff should be computed with reference to the following table.

For example, a project commissioned on 18-9-2008 would have a tariff of Rs.3.15 / unit upto 26-04-2009 and tariff of Rs.4.213 / unit (Rs.1.546 + Rs.2.667) from 27-04-2009 upto 17-9-2009, a tariff of Rs.4.228 / unit (Rs.1.561 + Rs.2.667) from 18-9-2009 upto 31-03-2010 and tariff of Rs.4.361 / unit (Rs.1.561 + Rs.2.80) from 1-4-2010 upto 17-9-2010. Tariff from 18-9-2000 upto 31-3-2011 would be Rs.4.338 (Rs.1.538 + 2.80) and from 1-4-2011 upto 17-09-2011 the fixed cost would be Rs.1.538 and the variable cost to be determined in the next tariff order. The illustration is tabulated below:-
