The M.P. No.13 of 2011 has been filed with a prayer to permit the Petitioner to continue the maximum ceiling limit of Rs.9/- per kwhr of the reliability charges as ordered in M.P. No. 16 of 2010 for the period from 1-6-2011 to 31-5-2012. During the hearing on 12-7-2011, the petitioner submitted a statement showing the landed cost and weighted average price in respect of power purchase for July, August and September 2011. The weighted average price per unit in respect of 350 MW for July, August, September 2011 is indicated

as Rs.5.92, Rs.5.80 and Rs.5.97 respectively. TANGEDCO indicated an administrative cost of 39 paise per unit. After hearing the petitioner the Commission passed the following

ORDER

On the basis of the figures furnished by the TANGEDCO for short term purchase of July, August and September 2011, the weighted average for the month of July is Rs.5.92 per unit, for August Rs.5.80 per unit and for September Rs.5.97 per unit. Loading the administrative cost of 39 paise per unit which takes care of distribution losses and interest charges, the total cost for the TNEB would be Rs.6.31 for July, Rs.6.19 for August and Rs.6.36 for September 2011. This will be the reliability charges to be levied for the evening peak hours from 6 pm to 10 pm for the month of July, August and September 2011, respectively. TANGEDCO submits that they are yet to obtain tenders for the period of October 2011 onwards. TANGEDCO is advised to float tenders for the period from October 2011 onwards and submit the figures by the end of August 2011 to the Commission. Terms and Conditions for the supply of reliability power prescribed in the earlier order would continue to apply to this order also.
