1. The above M.P.No.3 of 2012 praying for punishing the respondent and its responsible officers for non-compliance of the orders made in D.R.P.No.5 of 2010 dated 07-09-2010 came up before the Commission for admission on 16-04-2012. The Commission in the hearing dated 16-04-2012 held as follows:-

"The Counsel for the petitioner was present and his arguments heard. The petition was admitted. Notice to Respondent. The respondent is directed to file the counter within 4 weeks".

2. The above M.P.No.3 of 2012 came up before the Commission for further hearing on 20-11-2012. In the said hearing dated 20-11-2012, the Commission held as follows:-

"Counsel for both side were present. The Learned Counsel for TANGEDCO filed a copy of the proceeding of CMD, TANGEDCO in No.361 dated 17-11-2012 confirming that the outstanding payment shall be released in three equal monthly instalments. TANGEDCO is directed to inform the Commission when every installment is released to the petitioner. The matter shall be listed for review at an appropriate time".

2. The above M.P.No.3 of 2012 came up before the Commission for further hearing on 31-01-2013. On the said date namely, 31-01-2013, the Commission passed the following final order:-

#### **FINAL ORDER**

"Thiru Parthasarathy, Learned Advocate represented for counsel on record.

Learned Counsel for Respondent / TANGEDCO has submitted the additional affidavit confirming payment of all the three instalments. The prayer of the petitioner is complied with and the case is disposed off accordingly".
