**INTERIM ORDER**

P.P.A.P.No.1 of 2011 along with I.A.No.1 of 2011 came up before the Commission for hearing on various dates referred to above. The prayer in the said P.P.A.P.No.1 of 2011 is for a separate categorization and for fixing purchase price

for power supplied to Tamil Nadu Electricity Board (now TANGEDCO) Grid from M/s.Sakthi Sugars Limited, Sivagangai Co-generation Unit using coal in the place of bagasse in view of the tie up arrangement with M/s.Tamil Nadu Newsprint and Papers Limited for supply of bagasse in exchange of coal.

The Commission requires the following details so as to enable the Commission to pass suitable orders.

- a. Capital cost of the co-generation plant and the date of commercial operation, so that tariff can be worked out as a special case based on normative parameters, after prudence check.
- b. Cost at which bagasse is supplied by M/s. Sakthi Sugars Limited to M/s.TNPL.
- c. Cost of imported coal used by M/s.Sakthi Sugars Limited and compensation if any, paid by M/s.TNPL to M/s.Sakthi Sugars Limited.
- d. Details of barter deal, if adopted between the parties.

On receipt of the above details from the Petitioners, the above P.P.A.P.No.1 of 2011 and I.A.No.1 of 2011 will be posted for further hearing.
