The M.A.P. No.2 of 2013 has been heard on 18-10-2013, 27-01-2014, 17-03-2014 and on 30-07-2014. The Commission after perusal of records relating to the above M.A.P. and after hearing the Chief Engineer, Projects / TANGEDCO passes the following order:-

ORDER

The M.A.P. No.2 of 2013 has been filed by the TANGEDCO as a single petition for determination of the capital cost for the following projects:-

Sl. No.	Name of the Power Plant	Capacity in MW
1	Bhavani Barrage II Hydro Electric Power Project	2 x 5
2	Bhavani Kattalai Barrage II Hydro Electric Power Project	2 x 15
3	Periyar Vaigai I Hydro Electric Power Project	2 x 2
4	Periyar Vaigai II Hydro Electric Power Project	2 x 1.25

On a prayer made by the Petitioner to waive the court fee of Rs.91,000/- (Rupees Ninety One Thousand only) payable to the Commission in respect of the above projects on the ground that the same has already been paid while submitting the ARR for 2013-14, the Commission waived the said court fee vide P.R.C. No.2 of 2013 on 18-10-2013. When the M.A.P. has been taken up for hearing on 27-01-2014, as the petition was incomplete with respect to certain factual particulars, TANGEDCO was directed to file detailed additional affidavit in respect of each plant. However, on perusal of the additional affidavits filed by the Petitioner, the Commission felt that the capital cost for each plant has to be determined separately and independent of each other. The Commission therefore decided to direct the Petitioner to file separate petition for each of the said four projects so that effective hearings could be made and the capital cost determined.

Accordingly the TANGEDCO is directed to file separate petition for each of four projects for which M.A.P.No.2 of 2013 has been filed. The waiver of court fee granted by the Commission in P.R.C. No.2 of 2013 will hold good for such separate petitions to be filed. The M.A.P.No.2 of 2013 is closed.
