**ORDER**

M/s.Kaveri Gas Power Ltd., the Petitioner herein filed the above M.P.No.15 of 2013 with the prayer *inter alia* to punish the Respondents for the contravention of the directions of the Commission contained in the order of the Commission dated

21-02-2013 in R.A. No.3 of 2013 directing the TANGEDCO to treat the Company as STOA customer and refund the excess amount collected from the Company for the period from 19-10-2007 to 03-10-2008. The Commission disposed of the above M.P. vide its Daily Order dated 17-04-2015 directing the Respondents to settle the payment of arrears as agreed to by both parties. The Respondents, TANGEDCO have since filed a report dated 16-02-2016 stating that as per the direction of the Commission, the balance amount of Rs.17,27,664/- has since been refunded to the Petitioner M/s.Kaveri Gas Power Limited and prayed to dispose of the above M.P. The Petitioner M/s.Kaveri Gas Power Ltd. has also filed a report dated 17-02-2016 confirming the fact of receipt of the said sum. M/s.Kaveri Gas Power Limited has also prayed that inasmuch as the matter has been settled out of the Court the Petition may be disposed as closed. Since the matter is reported to have been settled out of the court nothing survives in the above M.P. Therefore the Commission orders that the above M.P.No.15 of 2013 be closed.
