1. M.P.No.25 of 2016 has been filed with a prayer to clarify-
 - (a) Whether order dated 17-04-2013 passed in D.R.P.No.21 of 2011 and others or order dated 13-02-2015 passed in D.R.P.No.41 of 2014 is to be followed;
 - (b) the method of calculation to be followed by the applicant in determining the quantum of excess demand and excess energy availed by the HT captive / third party consumer prior to 07-09-2010, in view of the findings of this Commission in order dated 17-04-2013 passed in D.R.P.No.21 of 2011 and others and order dated 13-02-2015 passed in D.R.P.No.41 of 2014.
 - (c) the date from which order of the Commission dated 07-09-2010 in M.P.No.9 of 2010, M.P.No.6 of 2010, M.P.No.17 of 2010 and D.R.P.No.9

of 2010 is required to be implemented for both captive and third party users.

2. The above M.P.No.25 of 2016 came up for hearing on 16-11-2016. Thiru S.P.Parthasarathy, Advocate for the 18th Respondent opposed for admitting the petition on the ground that the subject matter is pending before the Hon'ble Supreme Court. The Senior Counsel representing the Standing Counsel for the Petitioner prayed the Commission to permit him to withdraw the petition with liberty to file a fresh petition.

3. The Commission upon perusing the records and considering the prayer of TANGEDCO passes the following order:-

ORDER

M.P. No.25 of 2016 was taken up for hearing. The Senior Counsel for the Petitioner prayed to permit them to withdraw the case with liberty to file a fresh petition. The prayer is allowed and accordingly M.P.No.25 of 2016 is dismissed as withdrawn.
