1. The R.P.No.2 of 2016 has been filed by TANGEDCO to review the orders of the Commission dated 01-08-2016 wherein the Commission ordered to classify CMRL under HT Tariff 1 (B) for all connected load of CMRL and to meter the other loads like ATM, Kiosks, Stalls, Hotels etc. under miscellaneous category. Against

the said orders of the Commission, an Appeal has been filed by the Respondent, CMRL before APTEL.

2. In the above Review Petition, TANGEDCO has prayed to review the said orders of the Commission dated 01-08-2016 to the effect that until the consumer (i.e. CMRL) identifies separate load for traction and for other purposes, usage of load for mixed purposes including traction may be continued to be categorized under HT Tariff III.

3. The above R.P.No.2 of 2016 and I.A. No.1 of 2016 (for condonation of delay) in R.P.No.2 of 2016 came up for hearing on 13-11-2017. The Financial Controller, Regulatory Cell of TANGEDCO appeared and prayed to permit them to withdraw the above Review petition. No one appeared for the Respondent.

4. The Commission upon perusing the records and after considering the prayer of TANGEDCO passes the following order:-

ORDER

R.P.No.2 of 2016 and I.A. No.1 of 2016 in R.P.No.2 of 2016 were taken up for hearing on 13-11-2017. The Standing Counsel for the Petitioner prayed to permit them to withdraw the case. The prayer is allowed and accordingly I.A.No.1 of 2016 in R.P.No.2 of 2016 and R.P.No.2 of 2016 are dismissed as withdrawn.
