1. The P.P.A.P.No.12 of 2015 has been filed with a prayer for approval of tariff by the Commission for sale of power to Distribution Licensee in the State of Tamil Nadu from its 2.90 MW (Gross Power) Municipal Solid Waste (MSW) based Waste to Energy (WtE) Power Project at Pallavapuram, Tamil Nadu.

2. The above P.P.A.P.No.12 of 2015 came up for hearing on 13-11-2015 and 28-01-2016. Due to absence of the Petitioner on 13-11-2015, the case was adjourned. Thiru Rahul Balaji, Advocate represented for the Petitioner on 28-01-2016 and prayed time for filing Vakalatnama and Additional Affidavit due to change of the circumstances. The case was adjourned at the request of the Petitioner. Subsequently the Petitioner has filed an affidavit on 13-04-2017 seeking withdrawal of the Petition No.P.P.A.P.12 of 2015 with permission to file a fresh petition.

3. The Commission upon perusing the records and considering the prayer of Petitioner passes the following order:-

### **ORDER**

The Petitioner has filed an affidavit with a prayer to permit them to withdraw the case with liberty to file a fresh petition. The prayer is allowed and accordingly P.P.A.P.No.12 of 2015 is dismissed as withdrawn.
