The Petitioner, namely E.I.D. Parry (India) Limited has filed a petition on 16-06-2014 through its Counsel Thiru Rahul Balaji, Advocate with the following prayers, namely:-

- (i) set aside the communications received from the Respondent TANGEDCO bearing Letter No. CE/NCES/SE/Solar/EE/SCT/AEE1/F.EID Parry/D.387/13 on 24-07-2013 and Letter No. CE/NCES/SE/Solar/So1/SCB/A1/F.EID Parry/D.205/14 dated 07-03-2014.
- (ii) issued a direction to the Respondent TANGEDCO to permit wheeling of 0.70 MW of power from the Petitioner's 18 MW Pudukkottai Co-Generation Plant or from the Petitioner's 24.5 MW Nellikuppam plant to the Petitioner's Bio-Pesticides Division at Thyagavalli in Cuddalore having EB Service No.92; and

(iii) pass such further or other orders as this Commission may deem fit in light of the facts and circumstances of this case and thus render justice.

2. The above petition was scrutinized and numbered as D.R.P.No.57 of 2014. Before listing the above petition for admission, the Petitioner has filed Withdrawal Petition in D.R.P.No.57 of 2014 on 24-02-2015 seeking permission to withdraw the petition filed in D.R.P.No.57 of 2014. In the impugned letter of TANGEDCO dated 24-07-2013 and dated 07-03-2014, the request of the Petitioner for the supply of partial power to the Respondent Board after adjusting partial power against consumption of the Petitioner and wheeling of 0.7 MW of power from 18 MW co-generation plant at Kurumbur, Pudukottai District have respectively been rejected by the TANGEDCO.

3. The Commission upon perusing the records and considering the prayer of the Petitioner in the withdrawal petition passes the following order:-

ORDER

The Counsel for the Petitioner in his petition dated 24-02-2015 has prayed to permit them to withdraw the petition. The above withdrawal petition has been filed even before the main petition is listed for admission. The prayer in the withdrawal petition is allowed and accordingly D.R.P.No.57 of 2014 is dismissed as withdrawn without liberty to file a fresh petition.
