ORDER

1. Prayer of the Petitioner in D.R.P.No.31 of 2013 is to pass an order setting aside the impugned Notice dated 15-03-2013 issued by the second Respondent as illegal, arbitrary, without the authority of law and against the orders passed by the Hon'ble High Court of Madras in W.P.No.23116 of 2010 and orders in M.P.No.43 to 45 of 2010 passed by the Commission and consequently direct the second Respondent to fix the base demand and base energy quota in line with Circular Memo dated 11-02-2011 issued by the first Respondent and pass such further or other orders as the Commission may deem fit and proper under the circumstances of the case and thus render justice.

2. Prayer of the Petitioner in I.A. No.1 of 2014 in the above D.R.P. is to pass an Interim Direction, directing the second Respondent to permit the Petitioner to run the industry with 50% of their sanctioned demand and also give adjustment of the captive wind energy generated by the Petitioner upto sanctioned demand pending disposal of the main petition and thus render justice.

3. The Respondents have filed their Counter Affidavit on 10-04-2014 with a prayer to dismiss the petition as devoid of merits.

4. The above I.A.No.1 of 2014 in D.R.P.No.31 of 2013 and D.R.P.No.31 of 2013 was heard and reserved on 29-04-2014 by the earlier Commission and as one of the Members demitted office before pronouncement of the order, the case was posted for further arguments on 09-10-2018. During the hearing on 09-10-2018, the Counsel for the Petitioner submitted that R&C measures were not in force and therefore the prayer in their petition was not pressed. The prayer is allowed and

accordingly I.A.No.1 of 2014 in D.R.P.No.31 of 2013 and D.R.P. No.31 of 2013 are dismissed as not pressed.
