1. Prayer of the Petitioner in M.P. No.10 of 2019:-

The prayer of the Petitioner in M.P. No.10 of 2019 is to effect changes in the records maintained by Namakkal EDC, TANGEDCO so as to correct the land, in which the S.C. No.218-011-504 stands, as one bearing Survey No.30/4D instead of Survey No.26/5A which, according to the petitioner has been erroneously entered in the records of TANGEDCO, Namakkal EDC.

2. Facts of the case:-

It is the case of the complainant that the Grandfather of the complainant was originally the owner of the two lands bearing Survey Nos. 26/5A & 30/40 wherein a well was situated in Survey No.30/40 only. It is his further case that his Grandfather mistakenly applied for Service Connection in Survey No.26/5A where there was no well and consequently, the records continue to show as if the Service Connection is situated in Survey No.26/5A while the well is actually situated in Sl.No.30/40. In view of the same, the complainant has sought to effect correction in the records of TANGEDCO, Namakkal.

3. The above petition came up for hearing on 22-10-2019. The Advocate for the Respondent appeared before the Commission and submitted that the grievance of the petitioner has been settled and hence the petitioner has prayed to permit him to withdraw this petition. The petitioner has also sent a letter to the Registry on 22-10-2019 requesting to permit him to withdraw his petition.

4. The Commission upon perusing the records and considering the prayer of the petitioner passes the following order:-

ORDER

The Petitioner is permitted to withdraw his petition since the grievance of the petitioner has been settled by the Respondent. In the result, the M.P.No.10 of 2019 is dismissed as withdrawn.
