The Counsel for the Petitioner appeared and submitted that Execution Petition Nos.01 of 2018 in Appeal No.138 of 2013 and 02 of 2018 in Appeal No.137 of 2013 are pending before the Hon'ble APTEL in the subject matter of this Miscellaneous Petition and prayed the Commission to permit to withdraw the petition. The prayer is allowed and accordingly M.P.No.38 of 2014 is dismissed as withdrawn.
