### **ORDER**

**1. Prayer of the Petitioner in D.R.P. No.10 of 2014:-**

The prayer of the Petitioner in D.R.P. No. 10 of 2014 is to direct the respondents to forthwith make payment of a sum of Rs.11,18,484/- being the interest due for till March 2013 and payable to the petitioner against delayed payments made by TANGEDCO for power supplied and further direct the respondent for the future period to pay interest at 1% per month for any delay in settlement of invoices beyond the period of 30 days from the date of invoice and further direct the respondent to bear the costs of the instant petition including court fees and legal expenses and make payment of the said sum to the petitioner.

**2. Hearing held on 01-12-2020:-**

In the hearing held on 01-12-2020, Thiru Rahul Balaji, Advocate for the Petitioner has informed that TANGEDCO has settled the entire claim of the petitioner and hence the petition may be closed and ThiruM.Gopinathan, Standing Counsel for TANGEDCO has also sought for closing the matter as compliance has been made.
