1. Prayer of the Petitioner in D.R.P. No.63 of 2014:-

The above D.R.P. No.63 of 2014 has been filed with a prayer to pass an order directing the Respondents to make payment of a sum of Rs.116,216,508/- being the interest due and payable to the petitioner against delayed payments made till 31-05-2014 for power supplied from its Wind Energy Generators located at the project forthwith to the petitioner and to direct the Respondents to bear the costs of the instant petition including court fees.

During the hearing held on 28-01-2020, Memo has been filed by the petitioner agreeing to the offer of the TANGEDCO counsel for settlement of dues with interest @ 6% per annum within 60 days.
