The above M.P.No.21 of 2019 has been filed with a prayer to shift the Petitioner's Agriculture Service Connection No.166-009-530/TF IV, Pannaikudy Village, Madurai District and instruct the respondents to issue a cheque for an

amount of Rs.1000/- towards compensation charges within the time limit mentioned in the Electricity Ombudsman order in the Petition No. 62 of 2018 (Para No.9.1 & 9.2) dated 19-09-2019 and render justice to the innocent farmers and take stringent action against the above said two erring officials for not implement the Electricity Ombudsman / TNEB order and save the farmers life in Madurai District.

During the hearing held on 10-01-2020, Thiru Karuppaiah, Spouse of Tmt.K.Pooranavalli appeared for the petitioner and the Commission directed the TANGEDCO to comply with the order of the Electricity Ombudsman strictly. The shifting work has to be carried out under Deposit Contribution Work (DCW) System as per TANGEDCO's procedure. The DCW estimation to be intimated to the petitioner within 15 days from the date of this order and after receipt of DCW payment from the petitioner, shifting work has to be done within thirty days. The compliance should be reported before the Commission on 31-03-2020.

During the hearing held on 21-07-2020, the petitioner has sent a letter to the Registry on 19-07-2020 and informed that her grievance has been settled. The Standing Counsel for TANGEDCO appeared and prayed the Commission to close this petition as the Petitioner's grievance was settled.

The Commission after hearing the submission of the petitioner passes the following

ORDER

The Petition is dismissed as withdrawn.
