The above M.P.No.22 of 2016 has been filed with a prayer to issue appropriate directions in compliance with the judgment of the Hon'ble High Court of Judicature at Madras in its judgment dated 15-07-2016 in W.P. No.22097 of 2013

and consequently direct the Respondent to comply with the same in a time bound manner.

During the hearing held on 09-06-2020, the Counsel for the Petitioner submitted that this petition should not have been taken up by the Commission for hearing as a Remand Application (R.A.) and it should not have been numbered as a Remand Application (R.A.) by the Registry, since the orders of the Hon'ble APTEL in Para-12 in Appeal No.232 of 2017 is very clear and has directed the Commission to pass only a consequential order. The Counsel for TANGEDCO submitted that the TANGEDCO filed an appeal before the Hon'ble Supreme Court in this matter and the same is numbered. The Commission directed the Registry to close this petition as a Remand Application (R.A.) since it is unnecessary and appropriate orders in terms of the orders of the Hon'ble APTEL will be issued in due course.
