## **Tamil Nadu Electricity Regulatory Commission**

### **Notification No. TNERC/TR-5/2-2, dated 09-08-2007**

WHEREAS the Tamil Nadu Electricity Regulatory Commission specified the Tamil Nadu Electricity Regulatory Commission (Terms and conditions for the Determination of Tariff) Regulations, 2005 under section 61 of the Electricity Act 2003 (Central Act 36 of 2003) read with section 181 thereof and published the same in part VI – section 2 of the Tamil Nadu Government Gazette dated 3<sup>rd</sup> August 2005.

AND WHEREAS it is considered necessary to issue amendments to certain provisions of the said Regulations to remove some difficulties in implementing the Regulations to comply with the provisions in the Regulations framed by the CERC and such amending Regulations shall be subject to previous publication and has accordingly under gone such previous publication.

NOW, THEREFORE, in exercise of the powers conferred on it by section 61 of the Electricity Act 2003 (Central Act 36 of 2003) and all other powers enabling it in this behalf, the Tamil Nadu Electricity Regulatory Commission hereby specifies the following Amending Regulations to the Tamil Nadu Electricity Regulatory Commission (Terms and Conditions for the Determination of Tariff) Regulations, 2005.

### **TAMIL NADU ELECTRICITY REGULATORY COMMISSION**

#### **(TERMS and CONDITIONS for the DETERMINATION OF TARIFF) (Second Amendment) REGULATIONS- 2007.**

1) **Short Title and Commencement:**

- i. These Regulations may be called the Tamil Nadu Electricity Regulatory Commission (Terms and Conditions for the Determination of Tariff) Second Amendment Regulations 2007.
- ii. They shall come into force on the date of their publication in the Tamil Nadu Government Gazette.

**2) Amendment of Regulation 22 of the TAMIL NADU ELECTRICITY REGULATORY COMMISSION (TERMS AND CONDITIONS for the DETERMINATION OF TARIFF) REGULATIONS 2005.**

In regulation 22 of the Tamil Nadu Electricity Regulatory Commission (Terms and Conditions for the Determination of Tariff) Regulations, 2005 (hereinafter referred to as principal regulations), in sub-regulation (1), the second proviso shall be omitted.

**3) Amendment to regulation 24 of the Principal Regulations**

In regulation 24 of the principal regulations, the "**Note**" at the end shall be omitted.
